## **PERSONAL DATA**

Personal data is any information relating to an identified or identifiable natural person. Personal data that we process may include:

- Basic information such as your first and last name, prefix, title;

The information which we keep is limited to what you have provided when you applied, and may include personal or private email, phone and physical addresses, your resume and, if relevant, references or diplomas. We use this database for the management and administration of our recruitment process and potentially to contact you again should we deem your profile to be relevant for our ongoing needs. We have not and will not share this data with any other party and will not use your contact details for any marketing purpose. We may also collect your personal data from other sources, such as counterparties, the Trade Register or by using publicly available sources.

## **PURPOSES AND LEGAL BASIS FOR THE PROCESSING OF PERSONAL DATA**

Green Giraffe may process your personal data for the following purposes:

- To provide our services;
- To comply with legal and regulatory obligations;

## **RETENTION PERIOD**

## **SHARING WITH OTHERS**

Green Giraffe may share your personal data with any company belonging to the Green Giraffe group, for the purposes described in this Privacy Policy.

In some cases we may also share your personal data with third parties. This may include, but is not limited to:

- Third parties relevant to the services that we provide;
- Third parties that we engage with, such as supervisory authorities and other bodies, in order to comply with legal obligations;
- Third party suppliers in connection with the processing of your personal data for the purposes described in this Privacy Policy, such as IT providers, communication service providers or other suppliers to whom we outsource certain support services.
